



Capitol Connection Q&A for Contractors

Sometimes its good news, sometimes bad, or just in case! Whatever your issues my 'guidebook' is always open to finding a route, or re-route, to becoming a licensed contractor...

Q: You are currently assisting me with my pending "B" (General Building) application I submitted in late 2020, and as you are aware, I still have not been able to get approved to sit for an exam because the CSLB is not satisfied with the documentation I have provided to verify my experience doing "B" work. The main issue was when I originally submitted the application on my own, my certifier did not mention on my Certification of Work Experience that I had experience doing framing, paired with the fact my experience was not gained working for a Company with a General license. As you know, I've tried to provide additional documentation, however my name doesn't show up on any permits or contracts, etc. I was reading one of your recent articles about the new "B-2" Residential Remodeling Classification. Is it possible for me to change my application to a "B-2" at this point?

A: It sure is! The new B-2 license will open doors for many, many contractors in the same situation as you to become licensed. Obviously, you will still need *to verify* your experience as a qualified home remodeling contractor doing such work as kitchen and bathroom remodels, plumbing and electrical fixtures, cabinet installation, flooring, etc.

Q: I used to have a Sole Owner license and a corporate license in CA. Back in 2011, the corporate license was Revoked, therefore resulting in my Sole Owner license also being Revoked. I would like to get my Sole Owner license back if at all possible. Do you know what the requirements would be to make that happen?

A: Thank you for contacting Capitol Services Inc. The fact that it's been over five years since your license has been Revoked comes with both good news and bad news. The good news is five years is the maximum time frame in which a license can remain unable to be reinstated or reissued.

Even after five years, according to B&P Code Section 7102, the applicant is required to show that all conditions and monetary obligations have been fully satisfied and complied with. Bad news is as it's been over five years since you've been licensed, you will be required to go through the whole licensing processing again including re-testing, fingerprinting, etc. We would be happy to assist you with the process so please call our office if you want to move forward.

Q: I am a California licensed contractor and I am going to be retiring and moving to Arizona. I don't plan on continuing working however, I know there is a Reciprocal agreement between California and Arizona, and I figure it may not be a bad idea to get my Arizona license just in case I want to take on some small projects or subcontractor work.

Again, I don't anticipate any large projects. California has the rule of not performing any unlicensed contracting work over \$500 with labor and materials. Does Arizona have that same rule? I'm thinking I may be okay just limiting any work which may come up to \$500, but obviously want to confirm it's the same over there. Thank you for your time.

A: Arizona's rule is if the *entire* cost of the project, including labor and materials is over \$1000, *or* requires a permit by the local municipality, the person or business performing the work needs to be licensed. We can assist you in AZ, just in case.

Occupational Safety and Health Standards Board Votes to Adopt Revised COVID-19 Prevention Emergency Temporary Standards

Revisions Account for Rising Vaccination Rates, Offer Guidance to Help Businesses Reopen while Maintaining Strong Worker Protections

Revised Emergency Temporary Standards Effective Today

Sacramento—The Occupational Safety and Health Standards Board today adopted revisions to the COVID-19 Prevention Emergency Temporary Standards that account for recent guidance from the California Department of Public Health based on increases in the number of people vaccinated. Governor Gavin Newsom today signed an [executive order](#) enabling the revisions to take effect without the normal 10-day review period by the Office of Administrative Law—providing clarity and consistency for employers and employees as California fully reopens its economy. The revised standards took effect today.

The revisions include the following:

- Fully vaccinated employees do not need to be offered testing or excluded from work after close contact unless they have COVID-19 symptoms.
- Fully vaccinated employees do not need to wear face coverings except for certain situations during outbreaks and in settings where CDPH requires all persons to wear them. Employers must document the vaccination status of fully vaccinated employees if they do not wear face coverings indoors.
- Employees are not required to wear face coverings when outdoors regardless of vaccination status except for certain employees during outbreaks.
- Employees are explicitly allowed to wear a face covering without fear of retaliation from employers.
- Physical distancing requirements have been eliminated except where an employer determines there is a hazard and for certain employees during major outbreaks.
- Employees who are not fully vaccinated may request respirators for voluntary use from their employers at no cost and without fear of retaliation from their employers.
- Employees who are not fully vaccinated and exhibit COVID-19 symptoms must be offered testing by their employer.
- Employer-provided housing and transportation are exempt from the regulations where all employees are fully vaccinated.
- Employers must review the [Interim guidance for Ventilation, Filtration, and Air Quality in Indoor Environments](#).
- Employers must evaluate ventilation systems to maximize outdoor air and increase filtration efficiency, and evaluate the use of additional air cleaning systems.

Cal/OSHA is updating its resources to assist employers with understanding their obligations required by the revised emergency standards. The [webpage](#) contains an [updated fact sheet](#) and [Frequently Asked Questions](#) about proposed revisions to the emergency temporary standards. In addition, Cal/OSHA is currently updating its model [COVID-19 Prevention Program in English](#) and [Spanish](#) and information on planned webinars hosted by its Consultation Services Branch.

The [Occupational Safety and Health Standards Board](#), a seven-member body appointed by the Governor, is the standards-setting agency within the Cal/OSHA program. The Standards Board's objective is to adopt reasonable and enforceable standards at least as effective as federal standards. The Standards Board also has the responsibility to grant or deny applications for permanent variances from adopted standards and respond to petitions for new or revised standards.

PUBLIC WORKS CONTRACTOR REGISTRATION RENEWAL

DUE BY JUNE 30TH

Late renewal (between July 1 and September 30):

If a contractor bid on, was awarded, or worked on a public works project after their registration expired:

- a penalty of \$400 applies when the lapse in registration is accidental
- a penalty of \$2,000 applies when the lapse in registration is not accidental

First-time registration:

A penalty of \$2,000 applies when a contractor is registering for the first time and did any of the following in the past 12 months:

- bid or was awarded a public works project
- worked on a public works project

Renewal after September 30 or reactivation:

A penalty of \$2,000 applies when a contractor did any of the following in the past 12 months while unregistered:

- bid or was awarded a public works project
- worked on a public works project

Repeat violations:

Contractors who are found to be in violation of the registration requirement twice in 12 months can be disqualified from working in public works for up to 12 months at a time.

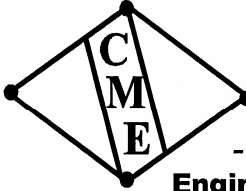

HEAT ILLNESS PREVENTION: ACCLIMATIZATION

INTRODUCTION

Acclimatization, or acclimation, is the process of slowly adjusting to new conditions. If acclimation is not done properly over time, the body may not be able to maintain optimal performance and you will increase your chances of heat illness.



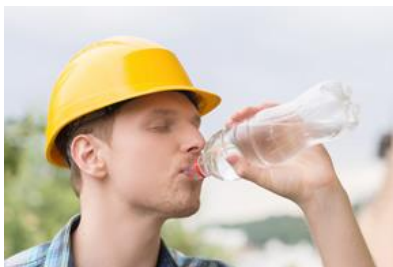
CONCEPT

Our bodies are designed to function perfectly in whatever climate we are typically in. For example, people living in high altitudes have adapted to require less oxygen for their everyday tasks because there is less oxygen available at high altitudes. People who live or work in high heat environments can only do so comfortably because their body has adapted to release heat more quickly and retain electrolytes more efficiently. Employees who are not used to working in high heat situations **MUST** be acclimated first or their body will not be as efficient and heat illness will follow.

METHODS

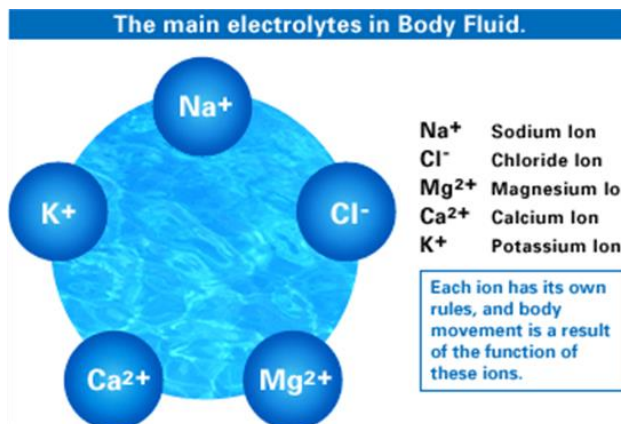
Heat acclimatization generally requires about two weeks of regular work for at least two hours per day in the heat. Employees will be closely observed by a supervisor for the first 14 days of employment to monitor the acclimatization process. During acclimatization:

- Employees should do the heaviest work of the day during cooler hours, if possible.
- At least two hours in the heat are required each day.
- Gradually increase your intensity level a little bit each day – don't push yourself too hard too early.
- Make sure you are drinking enough water – before becoming acclimated to the heat, your thirst reflex will not be very strong so you will have to remind yourself to drink even before you are thirsty (about one quart of water per hour).
- Employees who are not acclimated to the heat are required to take more frequent shade breaks than acclimated employees.



HEAT ILLNESS PREVENTION: ACCLIMATIZATION

- We recommend that employees get enough salt in their diets or replenish electrolytes with a sports drink while acclimating due to the dramatic increase of minerals lost through sweating.



SUCCESSFUL ACCLIMATION

After successful acclimatization to the heat, employees will notice a remarkable difference in the way their body reacts to high temperatures. This is because your nervous system will expect the heat sooner and make the necessary changes more quickly. Some of these changes will include:

- Reduced core temperature
- Increased sweating
- Decreased time between starting work and starting to sweat
- Earlier blood flow to the skin
- Lower body heat production
- Lower heart rate
- Increased thirst
- Reduced salt and electrolyte loss during sweating and urination



CONCLUSION

Acclimatization may not be rushed, because the body needs time to adjust. The majority of heat-related injuries and illnesses are due to improper or absence of heat acclimation procedures, so it is important that this step is not skipped or seen as optional!
